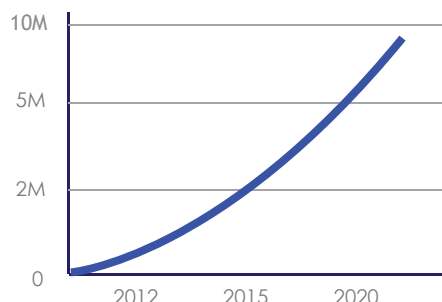

- Not a consistent wastewater parameters and flow.
- Not enough procedure and trainings to employees on wastewater processes.

SOLUTION

RSB provided a turnkey solution to our client including feasibility study, pre-designing of a wastewater treatment plant, selection of treatment chemicals, pilot on-site testing, final installation of the plant, test run, employee training, and reporting to Regulatory Agency within two months of time-frame.

In line with the client's needs and requirements from the regulatory agency, RSB proposed the installation and implementation of a Dissolved Air Flotation (DAF) system. The system consisted of a DAF unit, treatment chemical tanks, equalization tanks, sludge storage tanks, effluent wastewater tanks.
